**Programs Offered**

**Advance EMT-Hybrid**

The AEMT course is a limited enrollment program for course EMT168. The AEMT course starts Winter term. Students must apply for admission. Upon acceptance further information will be sent to the candidates Chemeketa Email outlining information surrounding uniforms, class layout, program specifics, and drug/background screening information.

Lecture is performed via Zoom with a synchronous requirement on Tuesday and Thursday evening from 1830-2130.

All Labs are mandatory: This class will have 7 labs that will cover a variety of skills and then the 8<sup>th</sup> lab will be the National Practical exam

**Who is Eligible to Apply**

The Advance EMT is a limited entry enrollment with an average of 24 students each cohort. The program accepts students in Winter term. Applicants must meet the following criteria to be considered for a position in the class:

- Completion of admission application packet found online.
- Current Oregon EMT
- AHA BLS card with acceptable expiration date
- EMT Experience: 6 months or greater
- Completed Vaccinations (See website)
- Completion of Drug/Background screening
- Application Fee payment \$40.00

**Admission Prioritization**

The following will be considered when selecting and prioritizing applicants for the program.

1. Completion of admission application packet found online.
2. Current Oregon EMT
3. AHA BLS card with acceptable expiration date
4. EMT Experience: 6 months or greater
5. Completed Vaccinations (See website)
6. Completion of Drug/Background screening
7. Application Fee payment \$40.00

## Estimated Program Cost

This is an estimated cost of the Advance EMT. For more complete breakdown of cost, you are welcome to inquire with faculty. Please be aware this is an estimate and the actual cost per individual may vary depending on several factors.

- AEMT Tuition (\$101 per credits, \$37 fee=\$138 per credit): \$1104.00 (Subject to change)
- CTE Class Fee: \$10 per credit: \$80 (Subject to change)
- AEMT Lab fees: \$550.00 (Subject to change)
- AEMT textbooks (variable): \$70.00-\$100.00 per term (Charged upon admission. Candidate may not opt of this fee.
- Vaccination cost (variable on needs): \$1100.00
- Uniform/PPE equipment/Physical (variable): \$300.00

**Estimated Total: \$3243.00**

**Cost without vaccinations or limited vaccinations: \$2143.00-\$2500.00**

**After course completion cost: *These fees are not included with the program cost***

- State licensure: \$165.00
- National Written Exam (Pearson Vue): \$110.00
- National Practical exam (variable on location): \$50.00-\$200.00
